1419. POLICE REPORT

1420. MINUTES

1420.1. The Minutes of Wednesday 12th November 2008 were agreed and signed as a true record by the Chairman.

1421. REPORT FROM THE TOWN HALL

1421.1. A letter from Parkwood Consultancy Services was circulated to Councillors. This relates to a 'Sporting Provision Feasibility Study' being carried out for Breckland Council. The Town Clerk and Deputy Town Clerk have a meeting with them set up for Thursday next week 18th December at 11am. This will be the first of a series of meetings with other groups in the town to be held in January. Initially they are meeting with the Town Council.

It was agreed for Cllr Wickerson to attend this meeting also as chairman of the Town Group, unfortunately Cllr Matthews is unable to attend as she is attending another meeting.

1421.2. Councillors were invited to have a drink with the staff in the office at 11am on 23rd December. A reminder was given that the office closes down on the 23rd December at 12 noon and we re-open in the new year on Monday 5th January at 8.45am.

1422.3. There are no late applications to consider. However notification has just been received of an appeal by William Hill Organisation Ltd in relation to 3PL/2008/1361/CU 44 Market Place, use of premises for A2 purposes as a licensed betting office. This follows the refusal of planning permission by Breckland Council.

It was agreed for the Council to re-iterate the previous comments made concerning this planning application.

1422.4. A letter and information relating to permitted development has been circulated to Councillors for information.

1422.5. There are occasions where notification of Development Control meetings will be received in between Town Council meetings. Cllr David Butters has taken it upon himself to represent the Council at such meetings where three minutes is given to explain or state the case for a particular application. It was recommended that the Council agree to Cllr Butters acting as the Council representative for all invitations to the Development Control Committee meetings, with the Council's comments on the application concerned forming the basis of the Council's three minutes.

It was agreed for Cllr Butters to represent the Council at Development Control meetings with the Council's comments on planning applications.

1423. FINANCE:

1423.1. Accounts for Payments for December 2008.

A list of payments were circulated to the Councillors.

The accounts for Payment for December 2008 were unanimously agreed

1423.2. Precept requirement for 2009/10.

The recommendation from the Finance & G.P. Committee meeting is to set a Precept of £193,428 for 2009/10. Cllr Wickerson endorsed Richard and staff for producing a document with 101 recommendations, very clear document and easy to understand.

It was agreed with 1 against to set the Precept for 2009/10 at £193,428.

1423.3. A request has been received to erect a seat and plaque on the Campingland in memory of Mrs. Phyllis M. Bird (nee Barnes) born Swaffham 1910, died Roehampton 2003, and Mrs. Ivy E. Smith (nee Barnes) born Swaffham 1918, died Louth 2007. A policy was discussed relating to this request and all further requests. The policy should state that the donor cover the cost of the seat i.e. the manufacture of the seat, delivery costs and installation plus a sum to be held by the Council for future maintenance. The sum should be equal to the cost of manufacture, delivery and installation. The donor shall pay all fees at the time of ordering the seat prior to installation. The Council shall give consideration if requested by the donor to pay the fee for general maintenance over not longer than five years (the first payment due prior to installation), a further administration fee of 10% shall always be added to the sum due in such circumstances.

It was unanimously agreed to grant permission for a bench to be erected on the Campingland in memory of Mrs Phyllis Bird and Mrs Ivy Smith.

It was agreed to set a policy for the donor to cover the cost of the bench, installation plus a maintenance fee equal to the cost of the manufacture, delivery and installation.

1423.4. Correspondence and report regarding compensation of £250 due to Mr. Davies, a request for a further allotment in addition to five that he has and to consider if business activity is taking place was circulated to Councillors. The correspondence with Mr. Davies relates to compensation of £250 previously agreed by the Town Council for moving allotments back in January of this year. The money was not paid as a number of inspections throughout the year have confirmed that rubbish was still on the allotments concerned. The allotments are now clear and the matter is referred back to the Council for re-consideration. It was recommended that an administration fee is charged to cover the amount of staff time wasted on this. Cllr Lister proposed and Cllr Jennsion seconded to pay compensation of £150.

The proposal was lost with 3 votes for and 6 against with 1 abstention.

Cllr Sharpe proposed and Cllr Skinner seconded to pay compensation of £250

It was agreed with 6 votes for and 3 against with 1 abstention.

With regards to the request for a further allotment added to the five Mr. Davies already has, it was recommended that permission is refused on the grounds of the general poor condition of existing allotment sites. It was also recommended that the Town Clerk is instructed to complete his research into establishing whether business activity is taking place at the five existing allotments. The legal position is that commercial cultivation can become an agricultural holding. There are special conditions attached to this though and in the interim period if commercial activity is proven then this is in clear breach of the allotment tenancy agreement. The notice period for change to take place is similar to that for the notice to quit i.e. 12 months. Then there is legality of the number of allotments currently held by Mr. Davies; this needs to be clarified. Cllr Wickerson proposed and Cllr Lister seconded to write to all allotment holders informing them that they are in breach of their allotment tenancy if they are selling any items produced on their allotment.

It was agreed with 7 votes for and 2 abstentions for the Town Clerk to complete research into any business activities taking place on the allotments. It was also agreed for the Town Clerk to write to all allotment holders informing them that they are in breach of their allotment tenancy if they are selling any items produced on their allotment.

It was agreed with 7 votes for and 2 abstentions to hold off a decision to Mr Davies request for another allotment until research has been carried out.

1423.5. A request has been received and circulated to Councillors from Mr. E. W. Hewson regarding an allotment rent. The Town Clerk resolved this issue with a compromise of allowing Mr. Hewson to pay half his allotment fee, as he was unsure whether he would be well enough to work on his allotment next year. Mr. Hewson has until April 2009 to pay the other half of his fee or to give up the allotment. This was an example where the time issues like this take on the reception desk far outweigh the money involved in rent or the unnecessary pressure put on staff.

It was agreed to allow Mr Hewson to pay half his allotment fee until April 2009.

1424. GENERAL CORRESPONDENCE:

1424.1. E-mailed correspondence with SCALGA & copy of notice regarding skips has been circulated to Councillors. The period for placing rubbish in the skips at both allotment sites has now passed, thanks was given to SCALGA for their assistance in this matter.

1424.2. Response to a request regarding a double burial and information held on file in respect of such a burial – Mrs. E. White. This was a difficult and sensitive issue for the Council to deal with as it related to a double burial, access to personal information and future contact relating to a particular grave. The Town Clerk took advice before responding to the request from Mrs. White who now confirms she is satisfied with the way this was dealt with.

1424.3. Booking details for Circus Tyanna (Ricardo) and a planned visit to the Recreation Ground 27th – 30th September 2009. This correspondence is confirmation of a booking for the Recreation Ground in September next year for Circus Tyanna.

1424.4. Correspondence with Sheila Kathleen Fowler (Church Warden) regarding various issues relating to the Churchyard. The correspondence deals with root growth around the trees in the churchyard, pollarding of trees, the general condition of the old memorial garden, the church clock and in particular work carried out by volunteers in the churchyard without the consent of the Town Council.

1424.5. Dates for house to house collections for the Charity Scope 6th to 26th April 2009 & 5th to 25th 2010.

1424.6. Late correspondence has been received from Mrs Polaine-Leonard which was circulated to the Council at the meeting. It relates to the moving of structures from allotments and potential newsletter information.

1424.7. Correspondence with Mr. D. Dunkley regarding various issues related to Tumbler Hill allotments was circulated to Councillors. There are a number of issues raised by Mr. Dunkley that the Town Clerk has responded to, but the Council may wish to consider any or all of these issues if appropriate:-

- Fencing in progress alongside the railway cutting at Tumbler Hill.
- Councillors attendance of the open day organised by SCALGA.
- Promises made in respect of access roads to the allotments.
- Allotment holders who have been put under notice for not cultivating their allotments.

1424.8. The Town Clerk gave a report to Councillors regarding a request by an allotment holder to keep some hives of bees at Shouldham Lane/Shoemakers Lane allotments. The Town Clerk has circulated the British Beekeepers Association Policy & Guidelines for Allotment Beekeeping. There followed a discussion.

It was agreed for a 12 month trial period be given and review this at the end of that period. It was also agreed to set a limit on the number of hives and that only British species of bees are kept.

1424.9. A consultation document regarding 'Codes of conduct for local authority members and employees – Department of Communities and Local Government has been received and circulated to Councillors. The deadline for a response is the 24th December 2008.

It was agreed to adopt the Codes of Conduct for local authority members and employees.

1424.10. A new 'Certificate of Compliance' for new or re-fix of gravestones issued by the National Association of Memorial Masons has been received. There are responsibilities for Memorial Masons and for Burial Authorities with regard to a new 'Certificate of Compliance' relating to a benchmark standard. This replaces period based guarantees (for a number of specified years etc).

It was agreed that the Town Council adopt the 'Certificate of Compliance' from the National Association of Memorial Masons as the required standard for erection of memorials in the Cemetery.

1424.11. A letter has been received and circulated from Cllr Charles Gunner regarding the 'Swaffham Flyer'. He has requested that the Council should help Swaffham Transport by contacting the County Council and Breckland Council as a matter of urgency. This is in relation to coaches using the bus stop areas near the former TIC. It is suggested they use the area in front of the 6th form centre as an alternative. Cllr Gunner addressed the Council and stated that he agrees with those who want to preserve the coaches that go to Thursford but wants to see that other transport is given enough space to carry out its lawful business. A further letter related to coaches has been received from Cllr Carol Baker (Pedlars Gold). The point is made that these coaches are a good thing for the town and help Swaffham Businesses to stay open and keep trading. The extra trade that these people bring to the town lasts for a period of 6 to 7 weeks. There followed a lengthy discussion. Cllr Jennison proposed to keep the status quo as it would have a detrimental effect on Swaffham if the Thursford buses went elsewhere.

It was agreed with 1 against to keep the status quo for the Thursford buses as it would be a detrimental effect on Swaffham if they went elsewhere confirming that no representation to Norfolk County Council would be made and no action would be taken

1424.12. A new model publication scheme for Freedom of Information Act from the Information Commissioner's Office has been received. It was proposed by Cllr Butter to adopt the new publication scheme.

It was agreed for the Council to formally adopt the Freedom of Information Act new model publication scheme.

The Town Clerk attended a meeting recently in Dereham. The position is that two contractors have been chosen from the preliminary list of 11 to submit a tender with a deadline set for the 1st January 2009. Each has been encouraged to make contact with the Town Council's regarding their core bid. There will be an opportunity of putting forward the three additional locations for cameras in the core bid, but no guarantee that they will be included by either contractor. It is a competitive tendering process that looks to deliver what is best for the five towns across the district. The technology is moving forward at a rapid rate and there are clauses in the contract that will allow for the technology to be improved year on year. Once a successful contractor is appointed then they will sit down with each town to plan or build in their specific needs.

TOPICS FROM THE PUBLIC SESSION

BUDGET – Good attendance of public at this meeting but a shame there was not the same at the budget meeting of last week. Town Clerk and staff were congratulated on the information supplied for the budget.

Questions were asked relating to the sale of allotment land i.e. is the decision to sell deferred, reasons for this and how long the current borrowing strategy sustainable? The council are in the market to sell Shoulder of Mutton but will not be giving it away and are trying to get Days Field into the local development framework. The council are borrowing internally with back up from an overdraft but this is not sustainable past two years. It would make financial sense to sell Shoulder of Mutton.

Thursford Buses – Been told that the Council are considering having coaches removed from the town, would be very concerned if this is the case. The public were informed that this issue was being discussed further on in the meeting.

Allotment – Feel administration charge is unfair. Business activity mentioned in letter sent, having been selling flowers etc for many years. He is registered disabled and he is gardening to help his condition.

Recreation Ground – Concerned with state of ground when the yearly circus leaves, big ruts are left after. As part of agreement the ground has to be re-instated.
